

## Speech rights threatened again by Obama administration

President Barack Obama is at it again. He misused his power to go after the Tea Party to try and squelch them with an enforcement agency known as the IRS by placing pressure and intimidating members because that organization was critical of his administration. Specifically, the regulations will define "certain communications that are close in time to an election and that refer to a clearly identified candidate as electioneering communications."

But, as of today, the IRS says that the law doesn't say that; the sky is actually purple, even though the words of the law remain the same.
